### **Connect & GGS API**

#### South Africa (ZA) - Change of data source

Creditsafe are enhancing their South African data by offering an enriched dataset through an alternative data source. This will mean that there will also be a change of Connect and GGS ids for South African companies.

Examples of the Id format change is below:

#### Connect

Existing: ZA-X-8234781278530765350~1390742 New: ZA-X-ZA0000066539

GGS

Existing: ZA048/X/8234781278530765350~1390742 New: ZA046/X/ZA0000066539

The new South African data feed will be available on the Connect Sandbox environment and on the test GGS 1.3 API on Monday 26<sup>th</sup> October.

The live/production switch over is expected on 16<sup>th</sup> November.

#### Indonesia (ID) - Identifier Change & Data Alterations

There will be a change of Id format and some minor adjustments to the data that is populated for our Indonesian company report. Some Company report properties will be removed and others will be added. If you wish to know exactly what these changes are please reach out to the following depending on what API you are integrated into (Connect: <u>Connect@creditsafe.com</u> or GGS: <u>GGS.Integration@creditsafe.com</u>)

Examples of the Id format change is below:

### Connect Existing: ID-X-12345 New: ID-X-ID00191766

GGS Existing: ID039/X/12345 New: ID049/X/ID00191766

The new Indonesian data feed will be available on the Connect Sandbox environment and on the test GGS 1.3 API from Monday 2<sup>nd</sup> November (this may vary between GGS and Connect, but the variance will be after 2<sup>nd</sup> November).

#### The live/production switch over is expected on 27<sup>th</sup> November.



#### Cyprus (CY) - New Country (Coming soon)

Creditsafe will be adding a new Country to their Connect & GGS APIs very soon. More details on this in a follow up communication.

#### Global Gateway Service (GGS) - SSL Certificate change

In December the SSL certificate used by GGS will be renewed with updated certificates. Further details such as the date and the new certificates will be detailed in a future communication.

### **Data Changes**

#### Spain (ES) – New data/adjustments

The local Spanish registry status property has been added under: additionalInformation.misc.registryStatus

Other Officials data has been added under: additionalInformation.otherOfficials

Proxy entries have also been removed from the Directors section. This data is already in test/sandbox/live Connect and GGS APIs.

#### USA (US) – Data adjustments (Expected 16<sup>th</sup> November or soon after)

additionalInformation.InquiriesTrend to be renamed to additionalInformation.enquiriesTrend. At the moment the properties are both returned in the US report output side by side. The child properties under this node will also be renamed. This can be seen now on test/sandbox/live Connect/GGS APIs so you can plan the work to move to the enquiriesTrend node now.

#### Japan (JP) – Data adjustments (Expected 16<sup>th</sup> November)

*negativeRating* property will be moved from *additionalInformation* property to the *additionalInformation.misc.* This is to maintain consistency to where this data property normally resides.

#### Italy (IT) – Data adjustments (Expected 16<sup>th</sup> November or soon after)

additionalInformation.workforceInformation.companyEmployees.q1NumberSEworkers, q1NumberEmployedWorkers&q1TotalNumberofWorkers properties will be removed. This data now resides under additionalInformation.workforceInformation.companyEmployees.q1Worker.
