- Perform Identity Verification Checks
- Audit Processes
- Upload Batch Files
- Export Reports

   Monitoring (business change notifications) available, you will now be notified of any AML and KYC risks on a daily basis enabling you to do full KYC in one place on a single platform



# Basic Workflow Overview

#### **Legacy Protect**

#### **New KYC Protect**


Note: In KYC Protect, you can start the flow at two points:

#### 1. Create an AML Search

a. This is the same process in our legacy Protect product (except it is known as creating an Investigation)

#### 2. Create a profile

- a. This is not available in our legacy Protect product
- b. This allows you to provide all KYB / KYC data before performing screening checks
- c. Creating a profile first also ensure all decisions, screening checks, ID&V, etc are fully audited
- d. This is our recommended starting point





# How to Update Your Existing Integration

Legacy Protect has fewer capabilities than KYC Protect. Protect was limited to basic Search and Monitor functionality. Below we outline how to switch your existing integration over to our new KYC Protect endpoints.

This document assumes you only want equivalent capabilities and are not implementing the new features for your initial migration. This is our recommended approach to make the switch to KYC Protect easier. This document only covers AML Screening, Creating a Profile and AML Monitoring.

#### **AML Screen**

#### Notable Changes & Improvements

- AML screening can be performed before and after creating a profile
  - o KYC Protect best practice is to create a profile before performing AML screening
    - This allows for a quicker screening process as key parties and UBOs can be screened in bulk (once relevant details have been provided in the profile)
    - Hits can only be managed on a profile
- To perform AML Screening on an entity and view the overview of hits, you need to call two endpoints (see 'Key AML Screening Endpoints' below)
- The endpoints to perform AML Screening have been separated into business searches and searches of an individual
  - This supports the new parameters added (see details below) and makes a clear distinction of which parameters are supported for business and individual respectively
  - Company, PLC, Trust, Partnership and Other Entity profile types should use the business searches endpoints
  - o Individual and Sole Trader profile types should use the individual searches endpoints
- Improvements to AML Screening have reduced false positive hits by 50% (in comparison to legacy
   Protect)

- You can now filter business and individual AML screening results by categories (datasets parameter)
  - AML categories refer to specific classifications or types of activities, individuals, or entities subject to Anti-Money Laundering (AML) regulations; these categories help identify and monitor high-risk customers, transactions, or businesses to prevent money laundering and financial crimes
- Individual AML searches can also be filtered by PEP tiers, to select PEP data of interest based on your risk appetite
- For reference:
  - o Current 'investigations' endpoints are now 'searches'
  - o Current 'records' endpoints are now 'hits'

#### **Profiles**

#### Notable Changes & Improvements

- In legacy Protect, the name of a profile can be updated and investigations can be added, however there are no other customisable data points (and no KYC data can be stored)
- In KYC Protect, profiles have a much larger list of capabilities:
  - Store KYC data to have a holistic view of the entity (including the organisation details, key parties and UBOs)
    - Profiles support different entity types, with relevant data points available per type
       (Types are: Company, PLC, Trust, Partnership, Individual, Sole Trader and Other Entity)
  - o Perform identity verification and link results
  - Set the profile risk and assign profiles to colleagues
  - Set your KYC status and assign a date for your next review
  - Store documents obtained as part of your KYC process
  - o Essentially, profiles in KYC Protect can act as a single point of your KYC process
- Note: In order to add a search to AML Monitor, it must be saved as part of a profile

#### Notable Changes & Improvements

- In KYC Protect, you can monitor specific AML categories
  - Available categories: Sanctions, Enforcement, Insolvency Register, State Owned Enterprise,
     PEP, Profile of Interest, Adverse Media
  - o This allows you to customise what you receive AML monitor alerts for
- Additional match % thresholds for monitoring have been introduced
  - You can now configure AML Monitor to alert of any changes with a 75 100 match % (in increments of 5)
    - Previously this was 85 100
- Improvements to AML Screening have reduced false positive hits by 50% (in comparison to legacy
   Protect), resulting in more accurate AML Monitor alerts
